Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Nrs. 23652.90 which shall be valid for 30 days beyond the validity period of bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. **DHARAUTI A/C, Ga 3.0- 19003000003000000001** at Nepal Bank Ltd, Sunalitaar Branch and submit the Receipt/Voucher of the deposited amount of cash along with the Sealed Quotation.
6. Technical and Financial Sealed bids must be submitted to the office of Chapakot Municipality, Syangja by hand **before 12:00 on 5<sup>th</sup> October, 2021**. Bids received after this deadline will be rejected.

The Technical and Financial bids will be opened separately in the presence of Bidders' representatives who choose to attend at **13:00 on 6<sup>th</sup> October, 2021** at the office of Chapakot Municipality, suntalitaar, Syangja. Financial Bid will be opened if only Technical Bid is passed by the Office of Chapakot Municipality.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
